Inspired Giving

Longtime Donors Richard & Virginia Hunsaker Make a Transformational Estate Gift to Hoag

It started as a ski date. College junior Richard Hunsaker asked Virginia Moses to join him on his fraternity's ski outing to Idyllwild. She came home with a broken ankle, and he came home with the conviction that he was going to marry her.

The couple had met two years before when he was the freshman class president and she was the class secretary at the University of Redlands, their alma mater. They graduated in June of 1952 and were married in July.

With a degree in education, Virginia taught kindergarten for two years while Richard served in the navy. Richard used the GI Bill to build a house on a lot in Glendora that his father had given them as a wedding present. Soon after, Virginia retired from teaching to become a mother and raise their children.

Building a Family and a Future

In 1966, Richard launched a real estate management company, building a profitable portfolio over five decades. But, one of the earliest financial successes that Richard points to was his endowment-building efforts as a longtime board member at the University of Redlands. He credits those early fundraising endeavors as the genesis of his tradition of philanthropy.

Four children, a move to Orange County and twelve grandchildren later, Richard and Virginia are in the fortunate position of being able to give back to causes they're passionate about — like the university where they first met, the arts and Hoag.

Inspired by People

As the Hunsakers have selected organizations to support over the years, they've always been inspired by the good work of people first and foremost. Richard says, "We feel inspired by the good things people are trying to accomplish, and we want to help."

Hoag donors since 1984, Richard and Virginia have watched Hoag grow from a small hospital into a significant community health care provider. When Richard was hospitalized at Hoag in 2004, the exceptional care he received left a profound impression on him. Feeling prompted to do more, Richard rolled up his sleeves and joined the Hoag Auxiliary, volunteering in the emergency room. His own experience as a Hoag patient added to his sense of compassion as he assisted patients and their families.

A Gift with Intention

The Hunsakers recently notified Hoag Hospital Foundation that they have included a transformational \$10M gift in their estate to support the work of the Pickup Family Neurosciences Institute as well as advancements in ophthalmology. In honor of their extraordinary generosity, the North Tower of Hoag Hospital Newport Beach has been named the Richard C. & Virginia A. Hunsaker Pavilion.

"We are incredibly grateful to Richard and Virginia Hunsaker for their commitment to Hoag," says Robert T. Braithwaite, Hoag President and CEO. "Their legacy of generosity and compassion will impact care at Hoag for generations to come."

Focused on philanthropy that benefits a good cause and motivates others to get involved, the Hunsakers are grateful to be making a difference at Hoag. "My wife and I hope that our gifts will inspire others to give, too," Richard says, adding, "It's the cumulative giving effect of many that makes the greatest impact." To that, Virginia adds, "This community is extremely lucky to have Hoag so close by. We don't need to drive to LA to receive stellar care — we have it right here."



CARE COORDINATOR AND PATIENT ADVOCACY PROGRAM

\$275,000 will fund one care coordinator for three years

Care Coordinators assist Hoag Health Center patients in getting the care they need while maximizing their time at Hoag. There to greet patients as they enter the building, the Care Coordinators are on hand to streamline a complex process by spending one-on-one time with patients and helping them access all of Hoag's services and specialized programs.

Some of the tasks Care Coordinators handle are scheduling tests and treatments, coordinating appointments among different departments and specialties, assisting with the preauthorization process and providing patients with itineraries for care. In 2018, Care Coordinators assisted 1,900 patients.

A Talent for Technology

David T. Ahn, M.D., Named the Dr. Kris V. Iyer Endowed Chair in Diabetes Care

An endocrinologist specializing in diabetes and metabolism, David T. Ahn, MD, joined Hoag's Mary & Dick Allen Diabetes Center as Program Director in July 2018. Dr. Ahn provides clinical oversight for Hoag diabetes patients in both the outpatient and inpatient environments. He also provides strategic direction for current programs and develops future programs. Since joining the Allen Diabetes Center, he's launched two new clinical research studies which he oversees.

In an induction ceremony in June, Dr. Ahn was named the Dr. Kris V. Iyer Endowed Chair in Diabetes Care. "We are thrilled to have Dr. Ahn on the Hoag team," said Kris V. Iyer, MD, senior vice president, chief administrative officer, HMTS. "His passion for patient care will significantly contribute to our mission of making a positive difference. Awarding him with an Endowed Chair will give him resources to innovate and advance care."

Integrating Technology

A nationally respected clinical leader on the rise, Dr. Ahn chaired the diabetes technology panel at the most recent American Diabetes Association Scientific Sessions in Orlando. In August 2018, he was invited to participate in a forum hosted by the Federal Drug Administration to develop guidelines for the regulatory approval process for software (such as smartphone apps) as a medical device. He's passionate about utilizing medical technology and mobile devices to empower and improve the health and wellness of people living with diabetes and other chronic conditions.



An Early Calling

Born and raised in Southern California, Dr. Ahn received both his undergraduate and medical school training at UC San Diego. After completing an internal medicine residency at Scripps Mercy Hospital in San Diego, he returned to UC San Diego to complete his fellowship in endocrinology. Most recently, Dr. Ahn served as an assistant clinical professor at UCLA Medical Center.

Dr. Ahn was inspired to his path as a physician by his early experience with chronic illness.

"My mom was diagnosed with type 2 diabetes when I was in junior high, and that life-changing event played a major role in my decision to pursue endocrinology. I want Hoag to be synonymous with comprehensive and outstanding diabetes care here in Orange County."

"The number of patients enrolled in these trials has doubled in the past year. Imagine the hope and gratitude those patients and their families feel knowing they're benefitting from these promising new treatment options."

The highlight of the event was stand-up comic Mack Dryden, who shared the moment when his physician told him that he was cancer-free. "Again, thanks to you wonderful warriors who are contributing to this cure, I'm still good today," he said. "I appreciate people like you and what Circle 1000 is doing to save people's lives every single day. Just remember that falling on your face is still moving forward!"

Circle 1000 was founded by Newport Beach resident and breast cancer survivor Sandy Sewell in 1987. She gathered a group of friends and asked each to contribute \$1,000. She also tasked them with asking their own circle of friends to participate. From the powerful bonds of friendship, Circle 1000 has grown to more than 1,000 friends who have collectively raised more than \$20 million for Hoag.

Make a Gift of the Heart

In 2006, on Christmas weekend, Melissa and Michael Lora had a serious wake-up call when Michael suffered severe jaw pain. They rushed to Hoag where he was treated by Subbarao Myla, MD, FACC, medical director of Cardiac Catheterization Labs at the Jeffrey M. Carlton Heart & Vascular Institute. When Dr. Myla found that one of Michael's arteries was 100 percent blocked, he and his team completed a life-saving procedure. To everyone's relief, Michael's heart suffered no damage.
